

Robust Growth of AIF in India

The alternative investment industry in India has witnessed significant growth in recent years, outpacing even the traditional mutual fund

As of FY22-23, AIF industry committed capital has grown to USD 100 billion, this represents a 5-year CAGR of nearly 50%, significantly higher than the growth of mutual fund industry and with a potential to reach USD 300 billion by 2028.

- > Need for investor education




